Health Center receives \$6.9 million to build complete second floor of expansion project

On October 8, 2010, the Health Center was awarded \$6.9 million in federal funding through the Federal Health Care Reform Affordable Care Act. These funds will support the build out of a second floor to further expand primary care, dental, and behavioral health services. When complete, our new facility will enable us to serve more than 7,000 new patients, in addition to the 33,000 who rely on us for their care.
